Community Standards Policy

Thank you for being a part of LINKWORLD. We strive to create a safe, respectful, and inclusive environment for all users of our platform. In order to maintain this, we invite you to review our Community Standards Policy. The following terms are applicable for any content, interactions, or activities conducted on our platform.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or plural.

Definitions

For the purposes of this Community Standards Policy:

- Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to HIMALAYA PEAK PTY LTD, Thinclab, 10 Pulteney Street, Adelaide, SA 5000, Australia.
- Service refers to the website and services provided by LINKWORLD.
- Website refers to LINKWORLD, accessible from https://www.linkworld.bio/.
- Content means any information, text, graphics, videos, or other material posted, uploaded, linked to, or otherwise made available on the platform.
- You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Prohibited Content and Activities

You are not permitted to engage in or post the following types of content or activities on the LINKWORLD platform:

Adult Content

We want to empower Linkers of all kinds to carve out their own space on the Internet, while ensuring visitors, including minors, can make informed decisions. Legal restrictions across LINKWORLD's international markets limit what content we can allow.

You may:

- Create links to adult content as long as it is legal in your region, does not advertise full service sex work, and is marked as sensitive.
- Advertise adult media that you create and sell on other platforms.

You may not:

- Upload adult media (e.g., images or videos), including nudity, to your LINKWORLD, including your avatar, link thumbnails, backgrounds, PDFs, or Link Apps such as store product images.
- Embed social media feeds that display adult content directly on your LINKWORLD.
- Advertise full-service sex work.
- Share adult content created with generative AI to impersonate another individual.
- Use LINKWORLD commerce or payment-locked links to collect payments or donations for adult content directly through LINKWORLD.

Hate Speech

LINKWORLD supports sharing beliefs and ideas, but we do not allow speech or content that:

- Incites harm, hatred, or violence.
- Discriminates based on race, national origin, religion, gender, sexual orientation, disability, or other characteristics.
- Glorifies perpetrators of hate, violence, or discrimination.

Electoral Fraud

Do not use LINKWORLD to:

- Impede local or national electoral processes.
- Mislead the public about voting, including where, how, or who can vote.
- Sell or attempt to sell your right to vote.

URLs

LINKWORLD usernames are meant for all users. You may not:

- Buy, sell, or hoard usernames.
- Secure usernames without the intent of using them or with the intent of profiting through resale, which is illegal in some jurisdictions.

Illegal Goods and Services

Do not use LINKWORLD to promote or facilitate the sale of regulated or illegal goods or services, including but not limited to:

- Alcohol (unless properly licensed)
- Controlled substances
- Tobacco products, including e-cigarettes
- Weapons or ammunition, including replicas without proper indicators
- Fireworks or explosives
- Body parts or human trafficking
- Endangered species or regulated plants/animals
- Counterfeit goods
- Recalled or stolen items
- Hazardous materials
- Gambling or betting services
- Surrogacy services
- Personal information, mailing lists, or ID documents
- Multi-level marketing schemes

Spam and Fraud

LINKWORLD prohibits activities designed to spam or scam users, including but not limited to:

- Linking to external sites that collect personal information under false pretenses.
- Creating multiple accounts to promote goods/services.
- Collecting affiliate funds by creating numerous accounts.

Harassment

You may not use LINKWORLD to:

- Intimidate, harass, bully, or threaten individuals.

Extremist/Terrorist Content

Do not use LINKWORLD to:

- Propagate, advertise, or collect funds for extremist groups or activities.

Child Harm

LINKWORLD has zero tolerance for content that harms minors, including:

- Child sexual abuse material.
- Solicitation of minors.
- Imagery that exploits or endangers children.

We report such cases to relevant authorities.

Self-Harm

Content that promotes or idealizes suicide, self-mutilation, or disordered eating is strictly prohibited. If you or someone you know is in crisis, organizations like 7 Cups or the 988 Suicide & Crisis Lifeline provide support.

Shocking or Violent Content

Do not post content intended to shock or disturb users, including:

- Gore, mutilation, or excessive violence.

Privacy and Impersonation

You may not:
